

## **Terms and Conditions for Use of Training Website**

These TERMS AND CONDITIONS FOR USE (“Terms and Conditions”) are made between The Internet Society and the Internet Society Foundation (collectively, “ISOC”) and any person (“User” or “You”) who uses or visits this site (collectively the “ISOC Training Site”).

- 6.1. These Terms and Conditions shall be governed by the laws of the Commonwealth of Virginia without respect to its conflict of laws principles. Any claim or dispute between you and ISOC that arises in whole or in part from the ISOC Training Site shall be decided exclusively by a court of competent jurisdiction located in the Commonwealth of Virginia.
- 6.2. If any provision of these Terms and Conditions is deemed invalid by a court of competent jurisdiction, the invalidity of such provision shall not affect the validity of the remaining provisions of these Terms and Conditions, which shall remain in full force and effect.
- 6.3. You and ISOC agree that any cause of action arising out of or related to the ISOC Training Site must commence within one (1) year after the cause of action accrues. Otherwise, such cause of action is permanently time barred.
